 - 3.b Monthly rental value of parsonage plus monthly utilities
 4. Your monthly salary, social security plus parsonage (3.a or 3.b)
 5. Fill in the member's contribution. If the member makes a remittance from income that will be taxed, check the first box and fill in the amount. If the remittance is made by the member or the organization through a salary reduction, check the second box and fill in the amount.
