

# 2019 CGGC Ministry Review Instructions

## CHURCH CONTACT INFORMATION

**Q1 Church Name:** The name of your church

**Q2 Region:** Eastern, Great Lakes, Midwest, Allegheny, Western, California, or Other.

**Q3 Contact Person:** Person filling out the ministry review form.

## INVOLVEMENT STATISTICS

**Q4 Members:** How many official members did you have listed "on the church roll" as of December 31, 2019. If your church doesn't have membership, simply put 0.

**Q5 Worship Attendance:** Average worship attendance. The total number of people present throughout the year divided by the number of weeks you met in worship.

**Q6 Discipleship Groups:** The number of discipleship groups such as Sunday School Classes, Missional Communities, Small Group, etc.

**Q7 First time professions of Faith:** The number of people who proclaimed Jesus Christ as their Lord and Savior in 2019.

**Q8 Baptisms:** The number of people baptized 2019.

**Q9 Dedications:** The number of children dedicated in 2019.

## DISCIPLESHIP AND LOCAL MISSION

**Q10 *We are growing in the grace and knowledge of our Lord Jesus Christ.*** As you think about the majority of people that represent your church is their spiritual growth taking place?

**Q11 *We are effectively making new and growing disciples.*** Overall, do individuals who are already Christian look and act more like Jesus? Are there people connected to the church who are taking steps towards becoming a Christian?

**Q12 *We seek to understand and serve our local community.*** Are you reaching out beyond the people of your church to those who are in your community?

**Q13 *Have you formed partnerships with local entities.*** Are you working with other groups and organizations in your community?

**Q14 *Any further comments, questions, or stories.*** This is open space for you to share anything with your Region or the General Conference in regards to discipleship or local mission.

## CHURCH DEVELOPMENT

**Q15 *We have an intentional leadership development plan.*** Do you know who you should be raising up to be leaders and how you are going to do it?

**Q16 *We sent someone into full-time or part-time vocational ministry in the last year.*** Did someone from your church become a pastor or staff member of a church, a Christian non-profit, or a mission field?

**Q17 *Who in your church should be invested in by the region or General Conference?*** Name a person or two who would benefit from training and investment by the denomination so they can serve your church more effectively.

**Q18 *Did you start a new worship service, discipleship group, or ministry in the last year?*** Did you start or add a new ministry of some kind in 2019?

**Q19 *Are you currently helping start a new church through prayer, people or funds?*** Does your church have any involvement in helping new faith communities?

## WORLD MISSIONS

**Q20 *How often does your church pray specifically for the lost around the world?*** Think about your church as a whole and how often they pray for the lost outside of your local community.

**Q21 *Have you sent out any mission or work teams globally in the past year?*** Did anyone from your church serve on a team outside of your local community?

**Q22 *Do you have any partnerships with global churches or ministries?*** Partnerships are consistent commitments to prayer, financial giving, and/or visits.

**Q23 *Do you have someone leading world missions efforts in your church?*** Who keeps world missions in front of the eyes of the church on a regular basis?

**Q24 *Any further comments, questions, or stories.*** This is open space for you to share anything with your Region or the General Conference in regards to world missions.

## PARTNERSHIPS

**Q25 *How could your region/eldership help your church to be more effective?*** How can your region (Eastern, Midwest, Great Lakes, etc.) walk alongside of your church with specific training and assistance?

**Q26 How could the General Conference help your church to be more effective?** How can the General Conference (our denomination's global office) walk alongside of your church with specific training and assistance?

**Q27 How could your church help other churches in your region/eldership?** Things such as prayer, finances, wisdom from experiences, trainings, etc. are common answers.

**Q28 How could your church help other churches across the Churches of God, General Conference?**

Things such as prayer, finances, wisdom from experiences, trainings, etc. are common answers.

**Q29 What do you appreciate most about being part of the CGGC?** This is an opportunity for a word of praise regarding your relationship with the denomination.

**Q30 Any additional comments?** This is open space for you to share anything with your Region or the General Conference that didn't fit anywhere else in the Ministry Review.

### **Q31 One Year Goal**

Use this sheet to help identify one goal for your church to reach in the next year. If you already have goals, just let us know what they are. If you don't have any goals, work through the page with your leadership to arrive at one.

### **Q32 Church Income**

This is money the church has received.

**Unrestricted Gifts** Generally, any funds received by the church through weekly offering or otherwise that aren't for specific purposes.

**Special, Designated Receipts** Any funds received for a specific purpose (such as a ministry, etc.).

**Dividends, Interest, Loan Proceeds** Any funds that the church received as a type of investment.

**Tuition Fee Income** Any funds received from the operation of a day care or pre-school type of ministry.

**Capital Campaigns** Any funds received for the specific purpose of a new building or building improvement that is over \$1,000.

**Miscellaneous, Other** Any other funds received that don't fit in the other income categories.

### **Q33 Benevolent Ministries**

This is money the church has given or donated.

**Tithe sent to the regional conference** Any funds sent to your region as part of your tithe (the region then sends a portion to the CGGC).

**Tithe sent directly to the CGGC** Any funds sent directly to the General Conference as part of your tithe that you didn't send through the regional conference.

**Designated offerings given for regional conference purposes** Any offerings made to your region for a specific purpose or ministry.

**Designated offerings given for General Conference Ministries** Any offerings made to the General Conference for a specific purpose or ministry.

**Any other CGGC related benevolences** Any offerings made to organizations or ministries related to the CGGC.

**Gift to other, non-CGGC ministries** Any other offerings made to ministries not associated with the CGGC.

### **Q34 Church Ministry Expenditures**

This is money the church has spent.

**Church Staff Compensation** Total amount spent on staff including salary and benefits.

**Church Operating Expenses** Monies spent on regular expenses like utilities, ministries, etc.

**Capital Expenditures** Any monies spent on new buildings or building improvements that are more than \$1,000.

**Payment on Indebtedness** Total amount spent for payments on debt.
